## **Allocation Reporting:**

The green bonds of \$325mn raised in FY 2020-21 have been issued under the Green Bond Framework as presented in the Offering Circular of such issuance and is aligned with the Climate Bonds Standard.

The bond proceeds have been used for subscribing to NCDs issued by entities belonging to ReNew Power group i.e. Restricted Group Entities which funds were further used for refinancing of renewable energy projects located across India resulting in reduced carbon emissions thereby contributing to the mission to fight against climate change.
