Terrorists kill SPO, Kerala CPM faces charges of family in Pulwama

The family of a Special Police Officer The family of a Special Police was (SPO) of Jammu & Kashmir Police was wiped out by a group of Jaish-e- Mohammad terrorists' late on Sunday night at Hariparigam Tral in the Awantipora area of South Kashmir's Pulwama district.

Meanwhile, a top Lashkar-e-Taiba (LeT) commander Nadeem Abrar, who was involved in several attacks on security forces and civilians in Kashmir, was arrested on Monday. "Top LeT commander Nadeem Abrar arrested. He was involved in several killings. Big success for us," IGP Kashmir zone Vijay Kumar said in a tweet.

According to police, Abrar was involved in the killing of three Central Reserve Police Force (CRPF) personnel at Lawaypora ear-Meanwhile, a fresh encounter also

According to a police spokesman, at least 2-3 terrorists had barged inside the home of a SPO and fired indiscriminately. His wife and daughter also received critical injuries and were rushed to the nearby hospital. Inspector General of Police, Kashmir range Vijay Kumar Monday visited the residence of the SPO and expressed sympathies with the bereaved family members and assured them that the terrorists involved in this barbaric act will be neutralised soon

Interacting with the media after meeting the family of the martyred cop Kumar said Jammu and Kashmir Police have been working at the forefront of anti-terrorist

"Last night, two terrorists, who seemed to be foreign terrorists, fired on one of our SPOs. When his wife and daughter came to rescue him, they fired on them too. They were taken to the hospital where they succumbed to their injuries. We are saddened by this incident. We will identify and neutralise them soon. There is a Jaish-e-Mohammed (JeM) in this area and it must be them," said the IGP.

protecting 'gold smugglers'

The ruling CPI(M) in Kerala is facing charges of protecting and safeguarding 'professional gold smugglers' in the State for the services rendered by the latter in cash, kind and other means.

The recent seizure of smuggled gold by the Customs Dept from Kozhikode International Airport has opened a pandora's box for the CPI(M). Leaders of the party declared that the CPI(M) would keep off people with track records of gold smuggling and criminal activities. But all those who have been identified

with gold smuggling are the ones who act as cyber warriors and professional musclemen of the party with links to top leadership. Arjun Ayanki and Akash Thillankeri, two young activists of the CPI(M) who have been named by the Customs Department have issued a threat to the CPI(M) leadership for dumping them at this hour of crisis. Arjun Ayanki's social media page is full of photographs featuring him with top CPI(M) leaders including Chief Minister Pinarayi Vijayan. Last week's road accident near Kozhikode airport which claimed the lives of five passengers in an over speeding car led the Customs and Police officials to another

group which was giving the former a chase. The race between the two groups from Palakkadu and Kannur were for the gold worth crores of rupees smuggked in through Kozhikode. But they were ignorant of the seizure of the smuggled gold made by the Customs officials on duty," said a Customs officials. According to high ranking Customs officials in Kerala, Kozhoikode has become the epicentre of gold smuggling and the operators enjoy political patronage. "There is a CPI(M) fraction in the Customs Department which make matters for us," said another Customs official who referred to the attempt on the life of Sumit Kumar, Preventive Commissioner, Customs in the month of February. The case was hushed up by political leaders despite Kumar's open announce ment that his life was in danger.

Akash Thillankery, in his social media post, has issued a warning to the party's Kannur district for dumping the duo following the seizure of gold and related incidents. "I as a dedicatred worker of the Left brand of politics is doing all that I could do to strengthen anti-Fascist forces. But the recent announcement by the district leadership of the CPI(M) that the party would keep off such people is like dumping us after exploiting our services.

Prez praises Railways | Over 40% of Kumaun Himalaya susceptible to moderate damage in case of major quake: Study

> New Delhi: More than 40 per cent of the fragile Kumaun Himalaya is susceptible to permanent displacement in case of earthquake of magnitude ranging from 7 to 8.6 Mw, warns a new study by a team of Scientists from the Wadia Institute of Himalayan Geology, Dehardun, an autonomous institute under the Department of Science and Technology (DST).

The scientists had carried out a probabilistic assessment of co-seismic andslides for the Goriganga valley located in the Kumaun Himalaya as it lies in the highest seismically active zone of the seismic zoning map of India. This research has been published in the 'Bulletin of Engineering Geology and the Environment' recent-

Several studies suggest that this region is prone to a great future earthquake of 8.0Mw or greater. The team of Scientists including Sandeep Kumar, Vikram Gupta, Parveen Kumar & Y. P. Sundriyal estimated the Newmark permanent displacement, which provides the distribution of predicted slope failure in the area.

It was found that more than onethird of the area was vulnerable to the co-seismic landslide and that earthquakes of magnitudes 7.0, 8.0, and 8.6 (Mw) might moderately damage the area of about 1459 km2, 1256 km2, and 1134 km2 in the study region, respectively.

This work is the first of its kind in the Himalayas region, in which earthquake-induced landslides have been explored in view of future major to great probabilistic earthquakes, said a scientist from the DST.

Kerala Guv Khan calls on Vismaya's family

KOCHI: In a rare gesture, hitherto unseen or unheard in Kerala, Governor Arif Mohammed Khan on Monday called on the parents of Vismaya, the young bride who was found dead under mysterious circumstances in her husband's house last week.

The Governor drove down to Vismaya's house at Kollam and consoled her parents and brother who could not control their tears when they recounted everything to the former. Governor Khan told Vismaya's parents that he stands by them and they are free to call on him for any help. "Vismaya, though I have not seen her, was like my own daughter. It is as a mark of my respect to those girls who lost their lives because of dowry harassment that I have come here," said the Governor. He spent more than 20 minutes with Vismaya's family members . After coming out of the meeting, the Governor set aside all protocols and spoke to the media. "There are laws and legislations against dowry. But still we see many unfortunate incidents like the young girls losing their lives because of harassment. The youth of this country, especially the media, should intensify their campaign against dowry, a social evil," the Governor told the waiting reporters. *PNS*

Review meeting convened on pending JEE and NEET

s lakhs of students across the country A stakes of students across and wait for the announcement of the dates for the revised schedule of the JEE Main 2021 and NEET 2021 entrance exams, the National Testing Agency (NTA) under the Ministry of Education (MoE) is likely to make an announcement in this regard by the end of this week.

MoE sources said a review meeting was convened on Monday on the issue of pending JEE and NEET. "The present timing could be conducive for the conduct of entrance tests before the country is hit by a probable third wave of the corona pandemic, the participants deliberated," sources said adding the JEE Main pending exams will be held be July end and August beginning and the JEE Advanced is likely to be scheduled for August end or September

beginning.
The NEET UG exam conducted for admission in MBBS, BDS, BAMS, BSMS, BUMS, and BHMS courses will also be announced simultaneously to end the speculations and anxiety within the aspirants, parents, institutions and all other stakeholders related to the professional

Sources said Education Minister Ramesh Pokhriyal was scheduled to interact with candidates and parents over the subject last week on social media but he ended up by conveying only a recorded message on the suggestions of MoE officials. "There was nothing concrete and there could have been a deluge of queries on JEE and NEET which the Ministry was not prepared to answer. This could have further raised the anxiety of the candidates," said

While the entrance schedule is yet to be notified, the admission brochure of the IIT entrance - JEE Advanced - has already been released by this year's nodal institute -IIT Kharagpur. This year's JEE and NEET were postponed twice due to the prevailing pandemic situation in the country. The JEE Advanced was earlier scheduled to be held on July 3 but it too was postponed. The decision comes in the wake of a MoE directive to offer the relaxation as several students had claimed that they could not appear for the IIT entrance exam last year due to the lockdown imposed by the state governments due to pandemic.

As per the IIT brochure released on Sunday while most rules remain as it is, some eligibility and admission rules keeping the pandemic in mind have been tweaked. Along with the JEE Main 2021 qualifying candidates, those who were eligible to appear for JEE Advanced 2020 but failed to appear in the exam will now be allowed to appear for the IIT entrance.

'This is a one-time measure valid only for JEE-Advance 2021. These candidates will be considered in addition to and not as part of the total number of candidates who would qualify from JEE-Mains 2021 for appearing in JEE-Adv 2021," as per the brochure. Till last year, an IIT aspirant had to score 75 percent or more in the class 12 board exams as mandatory eligibility for the JEE-Advance, but for this year the criteria has been relaxed considering the complete scrapping of the class 12 Board exams this

However, candidates should have appeared and cleared their class 12 exams and should be among the top 2.5 lakh successful candidates including all categories in JEE-Mains 2021, read the brochure.

State is biggest terrorist recruiting centre: Outgoing Kerala Police chief

KOCHI: On the eve of his retirement from Indian Police Service, Loknath Behra, Chief tling disclosure. "Kerala has become the largest recruiting centre of terrorist organisations. This is because of the high literacy rate among the youth in the State. The terrorist organisations prefer to recruit educated perons for the anti-national activities," Behra told media persons in his customary interaction before demitting office.

Orissa born Behra is the longest serving police chief in Kerala having taken up the job in 2016. He was responding to a query on the influence wielded by the Islamic State (IS) in Kerala. "The instances of educated youth joining the terrorist organisation has to be viewed seriously. These organisations will not hesitate to go to any extent to charm the educated and make them join the dreaded outfits. There are any number of persons who have joined them from Kerala," said

Maha gears up for 15L jabs a day

TN RAGHUNATHA MUMBAI

Having factored the anticipated "third wave" of Covid-19 in the State, the Maharashtra Government is gearing itself to administer 15 lakh doses per day.

Speaking at a function organised to a dedicated Covid centre built by the stare-Municipal Corporation (BMC), chief minister said: "In anticipation of the third Covid-19, we have to take extra precautions. Given that the incidence of Delta Pluc Covid-19 infections is increasing, we need to follow Covid-19 norms strictly. Keeping this in mind, we are making preparations to increase the vaccinations

to 15 per day". The Covid-19 centre that the MMRDA has developed at Malad in north Mumbai has 2,170 beds. Of these 2170 beds, 1,536 are Oxygen beds, while the 190 ICU beds. Similarly, there are 200 Oxygen beds for children, while 50 beds are paediatric ICU beds. Uddhav said that in addition to the Jumbo Covid-19 centre set up at Malad, the state govrrnment was planning to new jumbo Covid-19 centres in Kanjurmarg, Sion, Worli and also increase the number of beds in existing jumbo centres at NSCI Worli, NESCO Goregaon and Richardson & Cruddas Byculla to ensure that there are no shortages. The Chief Minister said that though beds may be going empty, the second wave had still not subsided in the past nearly five months.

State deaths down to 287

Mumbai: The Covid-19 deaths dropped to 287 while the infections went down to 6,727, even as 10,812 patients were discharged after full recovery from various hospitals in the State.

A day after the State logged 405 deaths and 9,974 infections in the state, Maharashtra witnessed the deaths drop by 118, while new cases went down by

Of the deaths reported on Monday, there were 101 current fatalities, while 186 were "old and hither-to unaccounted" deaths, which have been added to the state total Covid-19 toll as part of the ongoing reconciliation process.

As 10,812 patients were discharged from the hospitals across the State after full recovery, the total number of people discharged from the hospitals since the second week of March last year increased from 57,90113 to 58,00925. The recovery rate in the State rose from 95.91 pee cent to 95.99 per cent.

The total "active cases" in the state dropped from 1,22,252 to 1,17,874. The fatality rate in the State rose from 2 per cent to 2.1 per cent.

Ace athlete Mayookha fires salvo against Josephine, accuses her of helping rapist

 $T^{\text{hough she had to quit as head of Kerala Women's}} \\ Commission last week following widespread protests$ against remarks made by her towards a victim of domestic blence, M C Josephine, the CPI(M) leader found herself in another controversy on Monday.

Ace athlete Mayookha Johny, national record holder in triple jump, held a press meet at Thrissur on Monday and alleged that Josephine tried to hush up a sexual assault case that happened in 2016 to save the hunter. "The Police to whom we complained showed scant regard to us following the interference of Josephine and since then the hunter has been threatening the victim," said Johny. The athlete said that the victim was a close friend of her.

The incident happened in 2016. Johnson, the accused, has been tormenting my friend for quite some time. Though she saved herself on many occasions from the marauding Johnson, he once trespassed into her house and molested her. The man also filmed the victim in compromising position." Said Mayookha.

The victim filed a complaint against Johnson immediately after the incident. But the police, though kind enough to assure the victim of all possible help, Josephine who was a close friend of the accused entered the scene and hushed up the case. "Even after this, he continued to threaten the victim and tried to misbehave with her as he had the tacit support of Josephine," charged Mayookha Johny.

Though Josephine was removed from the post of Chairperson of the Womens Commission, she continues to be the member of the Central Committee of the CPI(M), the elite and apex policy decision making body of the party. The membership of the Central Committee of the CPI(M) is a coveted position because of the vast international contacts offered by the august body.

Central Delhi second-most rain-deficient dist in India rainfall against the normal of 53.3 cially considered the monsoon sea-

The India Meteorological ▲ Department (IMD)'s latest data shows Central Delhi has recorded just 8.5 mm rainfall this monsoon season so far and is the secondmost rain-deficient district in the country. The rain deficit in Kistwar district of Jammu & Kashmir is the largest in the country. It has recorded 5 mm precipitation against the normal of 68.4 mm— a shortfall of

93 per cent. Meanwhile weak monsoon conditions are expected to continue over most parts of the country until first week of July. This break monsoon will adversely impact the agriculture. This will also bring hot and humid weather conditions in north and northwest India.

According to the IMD, Central Delhi has received only 8.5 mm

84 per cent. In the national capital, East Delhi has received 19.2mm rainfall against the normal of 53.3mm – a dearth of 64 per cent. Northeast Delhi has gauged 20.7mm rainfall, which is 61 per cent below normal, and South Delhi got 22.2 mm – 58 per cent less than normal. Southwest Delhi and New Delhi have recorded 29.6 mm and 27.7 mm rainfall so far --50 per cent below their respective normal rainfall. North Delhi has received 37.7 mm rainfall – 33 per cent less than normal - and Northwest Delhi 29.8 mm rainfall 22 per cent below the average precipitation. Only West Delhi has received normal rainfall so far -53.5mm against the average of June 1 to September 30 is offi-
